Kirstine Douglas is located in North Wallacetown, Scotland & has been producing Show Horses and Ponies for 18yrs with a very high success rate. She breaks, schools and produces for her clients and very rarely has a horse/pony in the yard that has been previously shown under saddle.

Kirstine produces In-Hand. - All types; rides and competes in Ladies Classes & believes in turning her horses out to perfection. Prior to starting producing on her own she spent almost 5yrs training with Robert Oliver, gaining a tremendous amount of knowledge from him. Kirstine travels to all major shows through out Great Britain and Ireland and has a very high success rate including wins at Royal International Horse Show and Horse of the Year Show.

Kirstine will be judging in New Zealand immediately prior to her Appointment at the Grand Nationals.

Kirstine is currently on the judging panels: Sport Horse Breeding (G.B.)—Ride and Conformation (R.I.H.S. and H.O.Y.S Panels) British Show Hack, Cob and Riding Horse Association – Ride and Confirmation (R.I.H.S AND H.O.Y.S) PANELS, N.P.S. – Show Hunter Ponies Breeding, CHAPS –Ridden and Confirmation P.U.K/ - Ridden Hunters, and Show Hunter Ponies.

Mrs Anna Levy is located in Kent, SE England and is married with 1 child, Oliver who is 3 years old. Anna was Employed for 4 years as Head Girl to top UK Show Horse producer Robert Oliver. She has been a producer for 12 of Hunters, Hacks. Riding Horses and Side Saddle. Anna has won at all major Country Shows and qualified for HOTY for the past 10 years.

Her Judging Panel credentials include: Sports Horse Breeding, Show Hacks and Cobs, Ridden Arabs, Side Saddle Association. Anna has judged at all major shows in the UK including The Royal Show, Royal International and HOTY Show. Anna has also judged internationally in Ireland and South Africa. For the past 3 years Anna has been freelance instructing and riding, following the birth of her son Oliver.

IMPORTANT NOTICE TO ALL AFFILIATES & MEMBERS

It was determined at the SHC meeting of 3/3/09 that at all future SHC Grand National Qualifier Shows a new Rule will apply; please ensure your members are provided with notice of this change and that the relevant Show Program's Conditions of Entry clearly state this requirement.

“All horses being entered in Hack, Show Hunter, Led & Rider Competition at this SHC Affiliate Grand National Qualifying Show, are required to be registered with The National Saddle Horse Register no less than Two (2) Calendar months prior to the Closing Date of the Show. (Only exception is Breed Classes).

This Rule will not apply to any current Event where Rules are already circulated and time frame is insufficient.

This is an important change, please don't leave it to the last moment to NSH register your horses. There will be no more 'Pending' nominations received after the cut off period.

2009 Pitcher Partners Pacific Coast Hack Championships

The Grand National Qualifying 2009 Pitcher Partners Pacific Coast Hack Championships will this year be held on the 25th and 26th April 2009 at the Castle Hill Showgrounds. Judges for the Championship are Dale Plumb from Victoria, Briony Paine from Victoria and Leanda Phelps from NSW. It is important to note that this year there will be no heats in the Grand National Qualifying Classes. The judging of all Grand National Qualifying Classes will be judged by the system that has been used at the Northern NSW Hack Championships, where all horses or rider complete a short workout, they are scored by the 3 judges independently with the worst score dropping off.

Important changes this year are all led classes, including the Riding Pony Feature Show led classes and the Northern NSW Super Hack Spectacular Challenge will be judged on Friday morning, following the leds will be the First Season Ridden, Ridden phase of the Hack Challenge and the Grand National Qualifying Show Hunters Ridden. Saturday will start with the Grand National Qualifying Riding Classes, Ridden section of the Riding Ponies, Preliminary and Amateurs.
